for Full-time Secondary English Teacher (2022. Aug.~2024. Feb.)

Korean International School (Secondary) in Ho Chi Minh City, District 7 is looking for a dedicated and hardworking Full-Time EFL teacher. Only candidates in VN will be eligible to apply.

1. You are expected to meet the following requirements:

- ① Native English speaker from one of the following countries (USA, UK, Australia, Canada, New Zealand, South Africa, or Ireland) is recommended. Regardless of nationalities, teachers who received degrees from countries where English is used as an official language are also accepted.
- ② BA or above in any field. (3+ yr college degree).
- 3 Three years or more of teaching experience preferred*.
- 4 TESOL/TEFL/CELTA/Teacher's certification (100+ hr) Mandatory

2. Contract Term: 16th August 2022 - 29th February 2024

- Contract renewal will be offered at the end of the contract period.
- All newly hired teachers will be required to attend in-person orientation starting on August 12, 2022.

3. Job specifications (Full-time teacher):

- Teaching hours: about 21 classes (45-minute classes) / week, from Monday to Friday, and fulfilling administrative work associated with being a teacher during school hours. The school hours are from 8:10 to 16:30.
- Base Salary: 50,886,000VND for a month
- Model United Nations (MUN) experience preferred (Position for MUN coordinator)

- Extra allowance: Teaching supplementary classes after school or during vacation time will be compensated at an hourly rate.
- Half of your salary is awarded at completion of your contract.

5. Documents to be submitted.

- In order to issue the contract, the selected applicant needs to submit the following documents as soon as possible (within three weeks after the employment confirmation. Due to COVID 19, a minor delay may be possible.)
 - ① <u>Original diploma/certificate</u> notarized by the Ministry of Foreign Affairs and the Vietnamese Consulate in the applicant's home country.
 - ② <u>Original certificate</u> (i.e. Teacher's License, TESOL, TEFL, CELTA, etc) notarized by the Ministry of Foreign Affairs and the Vietnamese Consulate in the applicant's home country.
 - ③ <u>Criminal Record Check</u> in Vietnam (those who already reside in Vietnam) and <u>Criminal Record Check</u> in the Applicant's home country (those who reside outside of Vietnam) notarized by the Ministry of Foreign Affairs and the Vietnamese Consulate in the applicant's home country. A clean background check to work with children is required.
 - (4) Medical checkup in the designated hospitals (FV or CarePlus)
 - (5) 2 photos (4cm*6cm)
